In honor of Spartan's commitment, AL!VE plans to place a sign at the health park recognizing the donation, as well as placing recognition and photos on the "Generosity Window" in HGB's lobby. HGB will further celebrate the gift by hallmarking a large, well-trafficked community meeting space at AL!VE called "GATHER" with the phrase: "Brought AL!VE by Spartan Motors."

Additionally, Spartan today announced a \$30,000 commitment over the next three years in support of CharlotteRising, the regional offshoot of Gov. Rick Snyder's larger statewide "Rising Tide" initiative created to advance economic prosperity in ten communities across Michigan. The Rising Tide program is sponsored by the Michigan Department of Talent and Economic Development.

"The health and well-being of our workforce and the community in which they live is essential, and we look at AL!VE and CharlotteRising as benchmarks of excellence in terms of the contributions they offer to the region.
