Spartan Motors Names Automotive Analyst to Board of Directors

Her views of the automotive industry have been frequently quoted in major publications, such as Automotive News and other leading trade publications. Recent speaking engagements include strategy workshops for automotive suppliers in Michigan, France, Italy and Germany.

Korth holds a bachelor's degree from Western Michigan University and a master's degree from the American Graduate School of International Management. Korth also serves as a member of the board of directors of Shape Corp., an auto supplier based in Grand Haven, Mich., as well as the Economic Club of Grand Rapids. She was also a board member of Autocam, Inc., an automotive parts supplier in Kentwood, Mich., which has since become a private company. Korth also serves as a member of the Society of Automotive Analysts.
